- 1. March 15, 2021 Minutes Approved
- 2. 7:00pm Potential rezoning on 19 Street NW
  - Stirling Karlsen from Innurskape Projekts joined meeting. He currently holds the properties at 206,210,214,306 and 310 19 Street NW

## 206,210,214 19 Street NW

- Preliminary plans will request rezoning to MU-1.
- Building intended to be 5 storeys. Commercial at grade and 4 storeys residential with underground parking. Anticipating four commercial businesses, fifty residential units and fifty underground parking stalls.
- Shadow study completed.

306 and 310 19 Street NW

- Preliminary plans will request rezoning to MU-1.
- Building intended to be 5 storeys. Commercial at grade and 4 storeys residential units. Anticipating two commercial businesses and 20-24 residential units.
- Proposing to pave the pathway between 19 Street and 18A Street to the back of the property line to allow traffic to pull in off 19 Street and have access a parking garage. Will have a sidewalk for kids getting to school.

Discussion included:

- Committee expressed preference for a concurrent LOC and DP. That is not their current plan.
- 200 block development timeline is 2-3 years; 300 block development in 2-4 years.

- The buildings will likely have setbacks.
- Committee would like to see shadow study extended for 7pm as well. Current shadow study looked at 10am, 12pm and 4pm.
- City will conduct a Transportation Impact Assessment for these developments.
- Committee concerned with these developments prior to the Riley LAP being formalized.
- Innurskape plans to do engagement with the community.
- 3. 8:00pm Protected Bike Lanes Deferred until May meeting.
- 4. 8:30pm Riley Communities Local Growth Planning Project Updates
  - Council has voted to delay the Guidebook until May 2021.
  - Riley Communities Local Area Plan has also been delayed.
  - City hosting a Guidebook Report Back Presentation April 29, 2021.
