## 9. Community Events

- Skate with Santa held on December 22<sup>nd</sup> was a success, 60 plus kids
- February Winterfest event in February will have some organized outdoor shinny games and some external guests who will lead some activities/experiments outside. More details to come.
- Embrace the Outdoor grant approved for \$9200, utilizing dollars to purchase more outdoor benches, a 250 pound firepit, propane heater rentals for the Winter Carnival as well as fund our external guest lead activities.

# 10. General Manager's update

- 2 break-ins in December through health club doors, locks changed and adding more horns in and out of the building to alert, new steel doors required, and added security measures on health club doors, approximately \$20-\$25K in total damage/replacement
- Bookings Arena and gym are doing well, other 3 meeting rooms are not still booking up, Squash and fitness center doing well
- we are projected to finish \$272K ahead for the year in a good position
- We will not qualify for Q4 City of Calgary Covid funding but City of Calgary wage subsidy still to come in until the end of the year
- Capital Projects 2022 HVAC in dressing rooms- 3-month project (Needs to be completed by mid-September 2022) and flooring for hospitality rooms (above dressing rooms).
- Brenda advised we should make the most of our CGC application, as long as we can cover off the 25% and what we are applying for is eligible for funding.
- Jordan put forward a Motion to apply for CCG for HVAC, Go Getters lights, Gymnasium Fans, Janitor sinks and Upper Studio C Flooring for up to 75% of \$300,000 with remaining funds coming from the WHCA General Account. Cher 2<sup>nd</sup> the motion, all in favor. Approved
