Terms of Reference WHCA GREEN COMMITTEE

Date: January 2023

Vision/Purpose:

The Green Initiatives Committee will promote environmentally sustainable projects, events and education at the West Hillhurst Community Centre and in the community of West Hillhurst.

Mandate:

- 1. To create opportunities for neighbours to connect, and participate in events that promote sustainability and environmental stewardship in West Hillhurst.
- To help the WHCA facility and citizens reduce their carbon footprint.
- 3. Provide opportunities for West Hillhurst neighbours to learn more about environmental issues.
- Provide support where needed to WHCA staff with community gardens.

Vision/Purpose:

The building and management of sustainable community gardens to create a focus for neighbourhood engagement and environmental education while beautifying the grounds of the WHCA facilities.

Mandate: 1. To create opportunities for the people of our community to have a communal place to garden, 2. To have a beautiful place to congregate and connect with nature, contributing to the well-being of the community and its residents. 3. To encourage gardening for the enhancement of our environment and quality of life. 4. Create opportunities to learn/teach, bringing young and old together

Membership

Membership in the committee is open to all WHCA members, both General and Associate. A chair will be selected by the Green Committee members to represent the Committee and the Chair shall report to the WHCA board of directors on a regular basis.

Funding

Funds for the Green Committee will be provided by the general funds of the WHCA. The Committee shall provide an annual budget each spring to WHCA General Manager for review, after which it will be presented to the WHCA board of directors for approval. Note that approval from the City of Calgary (CNS or Parks groups) may also be required for some projects. The

Committee may separately solicit donations of goods, services and/or cash amounts; however, all must be reported through the WHCA accounting and records system.
